SMART WATER METERING SOLUTIONS: IT'S NOT JUST ABOUT THE METER

Smart water meters are reshaping the way that network operators' interface with their customers and manage their networks. However, you need more than a digital meter for smart water metering; you need a smart metering ecosystem that will measure water demands in a way that is used to influence customer water use behaviour and improve network management.

This March we collaborated with the Smart Water Infrastructure Group to explore the smart metering ecosystem from the point of view of both water suppliers and suppliers of metering technology. You can access a recording of the webinar online by clicking here

WATER EFFICIENCY REPORTING IN TAUMATA AROWAI'S NETWORK ENVIRONMENTAL PERFORMANCE MEASURE RULES

The Water Services Act 2021 introduces new requirements for Taumata Arowai to monitor and report on the environmental performance of certain drinking water, wastewater, and stormwater suppliers and their operators.

The proposed rules include waterloss and residential water use performance measures, that are designed to provide greater transparency about the performance of networks, the impacts they have on the environment and public health, and to contribute to the continuous improvement.

REFRESH OF THE WATER LOSS GUIDELINES

Over one fifth of the water supplied to our drinking water networks being lost through leakage. Amongst participants in the National Performance Review, more than 80% of network operators were found to have economic opportunities to reduce their water loss, benchmarked using the International Leakage Index. With this in mind, the Water Services Managers Group has provided funding to refresh Water Loss Guidance Materials. The NZ Water Loss Guidelines, authored in 2010 by Richard Taylor and Allan Lambert, have long served water suppliers with the necessary tools to firstly analyse and then reduce the level of water loss in a water distribution network. The current resource suite is available here
