Christine McCormack (WECAN Chair) and Bruce Franks.</p> <p>In June we held Perspectives on Data – A Water Break to the Regulator webinar. This webinar involved several committee members including Andy Gaul from Nelmac from an operational point of view, the data services from Wate Outlook and all the way through talking about water data ecosystem framework.</p> <p>A case studies webinar with an eye for the smart metering. This webinar was more of a real-life example in terms of water quality integration. Hugh Blake-Mason and Bruce Franks hosted this webinar with guest speakers from Christchurch City Councils Smart Water programme and Dunedin City Council – Ports of Otago water meter program.</p> <p>Our workshop at the Water New Zealand Conference & Expo 2022 in Christchurch, this was a transformation piece, and all the committee was involved in this and</p>

MoE is looking at rolling out a national program to put in place smart water meters as many schools don't know what the opportunities are around water management because they don't have any information. <p>5.</p>	<p>Smart Water Vision</p> <p>The illustration can be found here</p> <p>Michael gave a synopsis of the recent workshop held at the Water New Zealand Conference & Expo 2022, in Christchurch. This workshop was interactive and had about 45 delegates.</p> <p>Presentations from Lesley Smith, Water New Zealand, on the National Performance Review David Wyllie from Tonkin + Taylor gave a summary of 30 years of asset management planning, asset management planning cycles in the UK. It is really important to look to the past, and to look to how it's been done elsewhere. Then Lorraine Kendrick, head of NTU's Asset Management Operations, Stormwater workstream (AMOS) gave an update of what they're up to as well around integrated asset management planning across their water services entities.</p>																																																			

	<p>The interactive sessions where we looked at what were our aspirations of digital transformation with asset management planning and what might our future vision for digital transformation look like.</p> <p>We surveyed the delegates that attended the workshop and asked for additional feedback on what might be missing from the picture and where to from here. Some of the ideas we had, what might be a single galvanizing statement of intent, maybe a vision statement that we can all come under. Where did digital twins fit into this? two resounding themes, which a sort of at odds with each other, the importance of people, but also the importance of standardisation.</p>
