

Approved Backflow Technician (ABT) National Database



APPLICATION FOR INCLUSION ON THE ABT DATABASE

To become an Approved Backflow Technician (ABT), knowledge of backflow prevention and cross connection control is required. A prerequisite is that an **ABT shall have attended and passed an approved Backflow course of not less than 40 hours** based on the course requirements contained in Attachment 2 of the Backflow Prevention for Drinking Water Suppliers Code of Practice (including obtaining appropriate NZQA Unit Standards). **ABTs are also required to attend and pass refresher courses at least every three years** in order to maintain their ABT status. ABTs shall confirm that they have appropriate insurance. To be included on the national database **ABTs must also be current members of Water New Zealand** (membership renewed annually) and hold a **current copy of the Water New Zealand (Formally NZWWA) Backflow Code of Practice.**
