Proposal 9 - F	Prohibition on application of class 9.1 substances directly onto, into or over water	
Question 32	Do you believe that there should be a control in the HPC Notice that specifically prohibits the application of hazardous substances directly onto, into or over water?	64-66
	Yes.	
	The Drinking Water Standards of New Zealand prescribes Maximum Allowable Values for the presence of a number of hazardous substances that are harmful to human health. This includes a number of pesticides such as 1080.	
	While the proposed control only applies to pesticides, Water New Zealand believes there may also be classes of herbicides that should be considered under this control. Determination of what substances require labelling should be referred to The Ministry of Health.	
	We support the definition of water used in this document (which also includes underground water) however note that users of pesticides may face challenges identifying underground water sources and applying this control in practice.	
Question 33	Do you think there should be a requirement for the product label to include, where relevant, a statement advising people to not apply substances onto, into or over water?	64-66
	Yes.	
	Having a label on the pesticide container will be a more effective prompt of the risks of applying pesticides to water.	
	Currently identifying where pesticides pose risks to drinking water is difficult. Water operators are required to look through data sheets of pesticides to identify active ingredients and then compare those to the list of chemicals in the Drinking Water Standards, to identify if further testing of drinking water is required.	
	In addition there have also been a few new pesticides introduced into the market since the development of the Drinking Water Standards were issued in 2008. Ensuring the product is labelled is a means of keeping track of the contamination risks posed to drinking water by new products.	
	Most contractors applying pesticides won't be aware of the Drinking Water Standards, and by not advising of risks to Drinking Water users are unlikely to be aware a risk exists.	
	The more warnings that exist, the better the risks to drinking water supplies can be managed.
