9. APPOINTMENT OF AUDITOR 2019-2020

10. DETERMINATION OF SUBSCRIPTION RATES

The President advised in accordance with the Board's policy of changing subscription rates incrementally each year in line with the annual rate of inflation, there will be a 2% increase, rounded up to the nearest \$5, effective from 1 July 2020.

11. GENERAL BUSINESS

The CEO updated members on training and education, advising there is a proposal from Opus to re-establish the diploma course that is not currently being delivered. This course would be run by Opus and requires \$110,000 to go ahead. Connexis do not have the funds to cover this. JP suggested Water New Zealand puts some money towards making the diploma course happen. This could be done by invoicing members as was done for the certificate course.

Brent Manning suggested that there should be some project funding i.e. through the WSMG that could be used instead. JP advised the ownership of the training material would be owned by Opus, this funding is for extra capacity at Opus for the delivery of the course.

Roly Hayes advised the IP is owned by Ministry of Works and that Water New Zealand should ask if there is still a commercial interest with OPUS or NZWETA. It was queried how the changes to vocational education i.e. the new “super polytech” would affect this.

Rob Blakemore advised the material was owned by Opus and asked, “what’s it for?” The update would be expensive and what is Water New Zealand going to get at the end of it. What are the consequences if this doesn’t happen?

Steve Couper suggested starting to talk to central government about how this may work and the possibility of it providing funding.

Rob Blakemore advised when Opus ran diplomas, they barely broke even. He suggested there was a need for the wastewater diploma as well.

Anthony Wilson advised there needs to be a transitional period between the old qualification and the new qualification. He also suggested the super polytech is not likely to see water training as a priority.

Ulrich Glasner suggested seeing what Australia was doing in this space.

Kelvin Hill advised the purpose of the discussion was to float the idea with the members and that a paper will certainly be circulated before any decisions are made.

Other Business

Anthony Wilson paid tribute to Mike Petricevich who recently passed away.

There being no further business, the President declared the meeting closed at 5.33pm.
