SPOTLIGHT - GLEN BURR

Glen was born in Auckland and is a proud JAFA. The son of a plumber, he naturally gravitated towards the trade, completing his apprenticeship by working for DH Wright. Not long after this he started his own business and completed his Craftsman exams in Plumbing, Drainlaying, Gasfitting. From there he made the logical step to train for Backflow testing, becoming IQP registered and has held the qualification for nearly 25 years. It is in Backflow Prevention that Glen found his true passion in the trade, with this becoming an everyday item for him and his company, Wet N Wild Plumbing. This passion stems from the fact that he loves testing valves and doubly so because they are so important in protecting our most valuable natural asset; Water.

Early on, Glen discovered that the passion he had for the trade gave him an extra calling in life; to pass this on through training and education. He created two courses for the old Plumbers, Gasfitters and Drainlayers Board CPD program, which were offered free of charge to practitioners who came to NZPGDA events. He then moved onto the development of the Plumbing, Drainlaying and Gasfitting qualifications through Skills NZ and learned a lot from this experience. Later he was approached by Building Networks to run refresher courses for IQPs, notably as the average IQP can sometimes be overwhelmed from forms, red tape and being caught between Compliance companies and the Council. These were a great hit amongst practitioners because they were being taught by a fellow IQP person. In return Glen got a great buzz from seeing others learning, sharing ideas and building on their knowledge. Glen has stated that what makes him happy is to motivate others to complete their qualifications and to know that he has contributed to that. Training a new generation of competent and passionate testers is very important to him and he has just recently completed his Graduate Diploma in Tertiary Teaching which has helped him in both his teaching space and personal space.

His list of credentials is impressive: He is President of NZPGDB. He provides a Backflow IQP Registration course approved by WIPA, focused on helping Backflow IQPs navigate the minefield of forms, procedures and responsibilities for Auckland Council. He's a technical committee member of Association for Building Compliance for backflows and runs refresher courses for them. He is also a proud member of the Water New Zealand Backflow Group.

In his spare time (which given his work commitments, is very little!) he likes to hand out with this family and when he gets a long weekend he is often found at the family bach in Mangawahi. He also loves flying drones for recreation and taking photos where possible of our great country. If you are ever in Mangawhai and see a drone overhead, don't forget to wave to Glen.



Group Workplan Update

1. WS-014 / WS-023

Both Wayne Shields and Richard Aitken are inputting into these Committees along with our BPAA colleagues. Some of the key factors will be ensuring joint standards are reflective of the current market and making sure that a consistent approach is applied on both sides of the Tasman.

2. G12 Update

The group will be working with MBIE to go through proposed changes to G12 to be reflective of the current state of backflow prevention and in doing so make it more coordinated with the new Water Services Bill.

3. Backflow Training

Mumtaz Parker from Water New Zealand has picked the brains of the group (she had to use a magnifying glass on most us) to put together an entry level understanding of backflow prevention that can be use3d for staff training. Water New Zealand will launch Backflow 101 around mid-April.

4. Code of Practice

The Backflow CoP remains in a holding pattern until the Backflow Rules are finalized. The existing CoP has been updated to reflect the new Legislation.

5. Survey Unit Standards

A big part of the new regime will focus on property surveys to ensure that cross connections are addressed. Getting a properly accredited survey programme will be a challenge and survey experts Richard Aitken and Jon Lewis will be driving this forward.

6. Backflow Rules

The Rules laid down by Taumata Arowai are still in draft form and will need to be finalized. These Rules will underpin everything that the new Bill is trying to accomplish with regard to backflow prevention so we must make sure they are fair, effective and robust.
